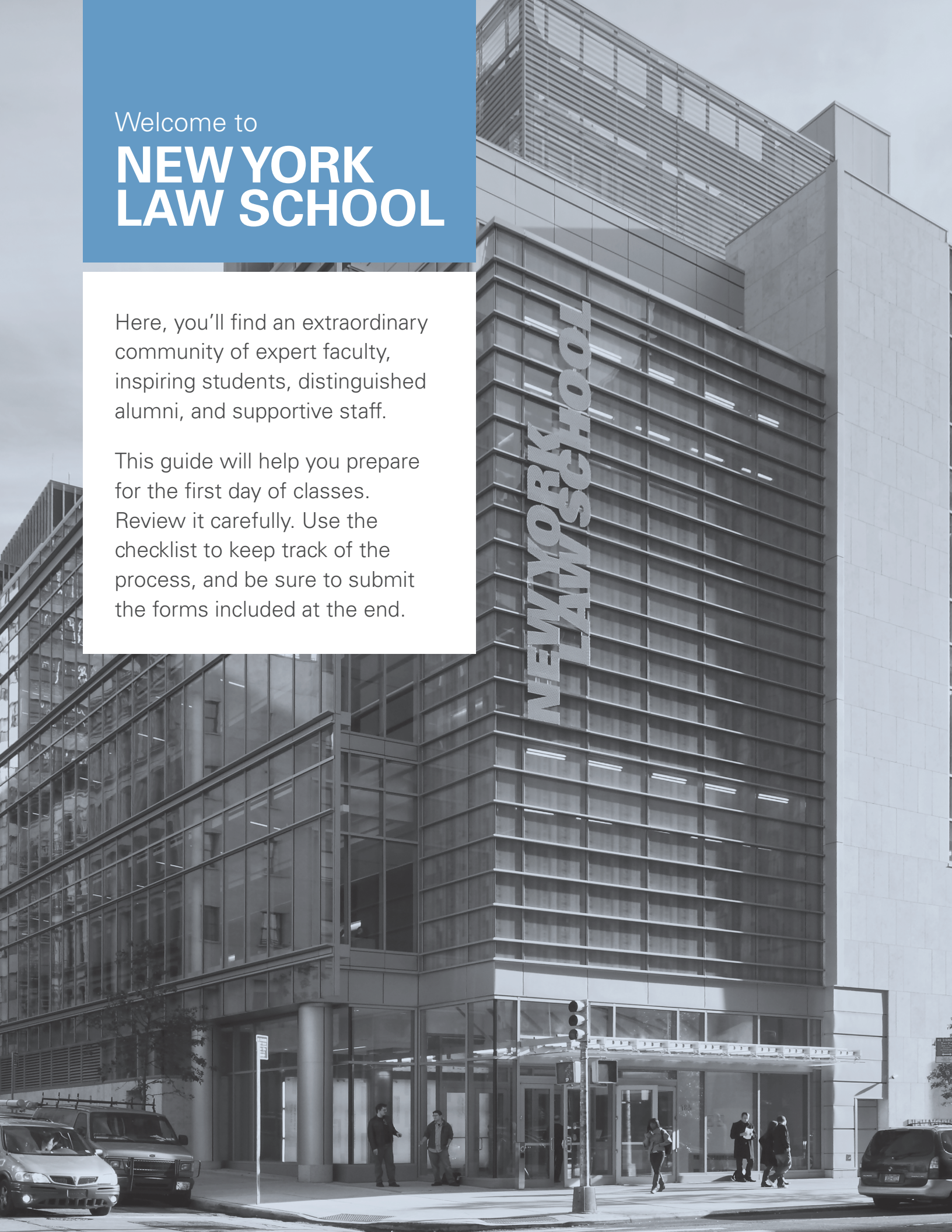

ADMISSION RESPONSE FORM

This form represents your official acceptance of NYLS's admissions offer. If you plan to accept the offer, complete and submit it, along with your first tuition deposit (\$300), by the deadline in your acceptance letter. If you decide to decline NYLS's offer, please still submit this form with the appropriate box checked.

TUITION DEPOSITS

NYLS requires *two* nonrefundable tuition deposits, totaling \$800, to confirm your decision. The due dates for both deposits are included in your acceptance letter. Deposits may be paid by check, money order, or credit card (Visa or MasterCard). When submitting your tuition deposits online, please make sure to have your Law School Admission Council (LSAC) or "L" number. This will ensure that the deposits are credited to your account. NYLS will confirm receipt of your deposits by email and through the Online Status Checker.

DEFERMENT REQUESTS

You may request to postpone your attendance at NYLS by emailing an explanation of the reasons for your request to the Admissions Committee (admissions@nyls.edu). You will be notified of the decision in writing, and if the deferment is permitted, it will be valid for one year. In addition, you must agree to all of the following terms and conditions:

- You will withdraw your applications to other law schools.
- You will *not* request a deferment from another law school.
- You will *not* apply to any other law school during the next admissions cycle.

If you defer admission, you must submit four nonrefundable deposits, totaling \$1,600. The first two deposits (totaling \$800) must be submitted by the deadlines in your original acceptance letter. The following year, NYLS will ask you to submit a second set of deposits (totaling \$800), to reaffirm your commitment to attending the School. All deposits received will be applied to your tuition charges when you matriculate the following year.

CONTACT INFORMATION

Between now and when classes begin, NYLS will be in touch with you regularly to share important updates and information. It is vital that the Office of Admissions and Financial Aid (admissions@nyls.edu) have your latest email, mailing, and phone contacts.

If you will not be reachable during specific dates, you may submit written authorization to the Office to have a spouse, family member, or friend act on your behalf to change your contact information or discuss your attendance or financial aid. Absent this written authorization, NYLS will *not* share any information about your application and admission.

DISCLOSURE/CHARACTER AND FITNESS

You must notify the Office of Admissions and Financial Aid (admissions@nyls.edu) of any changes to the information in your original admission application, including any changes to the Character and Fitness section.

In particular, you must tell the Office immediately if you have been cited, arrested, taken into custody, charged, tried, or convicted—or if you pleaded guilty—in relation to any felony or misdemeanor, or the violation of any law, except for minor traffic violations.

If you are unsure whether an incident meets the above standards, consult the Office.

Failure to disclose this information may result in revocation of your admission decision, dismissal from NYLS, revocation of any degree awarded by NYLS, denial of admission to the bar, and referral to the LSAC Subcommittee on Misconduct and Irregularities in the Admission Process. Information disclosed after an applicant has been offered admission will automatically result in a re-evaluation of the applicant's file.

ADMITTED STUDENT PORTAL

NYLS's Admitted Student Portal houses required forms, financial aid resources, policies, deadlines, and information about upcoming events. Visit www.nyls.edu/admitted to access the portal's login page. Enter "NYLSADMIT@nyls.edu" in the email field, and select enter. You will be redirected to a different page, and a box will appear, requesting your username and password. Enter "NYLSADMIT" for your username and "NYLS2019" for your password.

In mid-July, the portal will be your first stop for all updates relating to First Week orientation, class schedules, and directions for setting up your personal student portal and email address.

THE SUMMER ADVANTAGE INSTITUTE

During July and August, NYLS gives incoming students the chance to get a jump start on their legal education by enrolling in one of two Summer Advantage Institute (SAI) programs. The *extended program* takes place in the evenings during a three-week period before the start of school, while the *intensive program* consists of all-day sessions for one week in early August. The programs are free and are taught by NYLS faculty members. Topics include critical reading, case briefing, time management, outlining, and preparing for exams. SAI participants will also have the chance to complete a mock law school exam and get individualized feedback. NYLS strongly encourages you to participate in an SAI program and will notify you with more details and instructions for how to sign up.



Prospective employers I met during on-campus interviews were floored by my ability to keep a full-time job, attend law school at night, and be involved in on-campus activities. New York Law School has given me the opportunity and the resources to excel as a law student while upholding my work obligations.

FIRST WEEK

The academic year begins on Monday, August 12, 2019 with a combination of fall semester classes and orientation sessions called "First Week." In mid-July, NYLS will send you a schedule of First Week events and assignments. Attendance is mandatory the entire week, and you are expected to be available Monday through Friday, 9:00 a.m. to 5:45 p.m. (Day Division), or Monday through Thursday, 6:00 p.m. to 10:00 p.m. (Evening Division).

CLASS SCHEDULE

In early August, you will be notified that your first-year class schedule is available to view on the Admitted Student Portal. Please note that all students are expected to be available for classes scheduled anytime Monday through Friday, 9:00 a.m. to 5:45 p.m. (Day Division), or Monday through Thursday, 6:00 p.m. to 10:00 p.m. (Evening Division). Schedules cannot be changed except in the most exigent of circumstances, and all changes must be approved by the Associate Dean for Academic Affairs and Student Life.

CHANGING YOUR DIVISION

You may request to move from the full-time Day Division to the part-time Evening Division (or vice versa) only after successfully completing your first year. The Associate Dean for Academic Affairs and Student Life must approve your request. If you have a merit scholarship and are moving from full-time to part-time status, the scholarship amount will be adjusted accordingly.

TUITION AND FINANCIAL AID

- Fill out a Free Application for Federal Student Aid (FAFSA) by February 1, 2019 for priority consideration. (NYLS's code is G02783.)

TUITION AND FEES

NYLS typically determines tuition and fees for entering students the summer before their first academic year. The School will notify you of the 2019–20 tuition and fees as soon as they are determined. 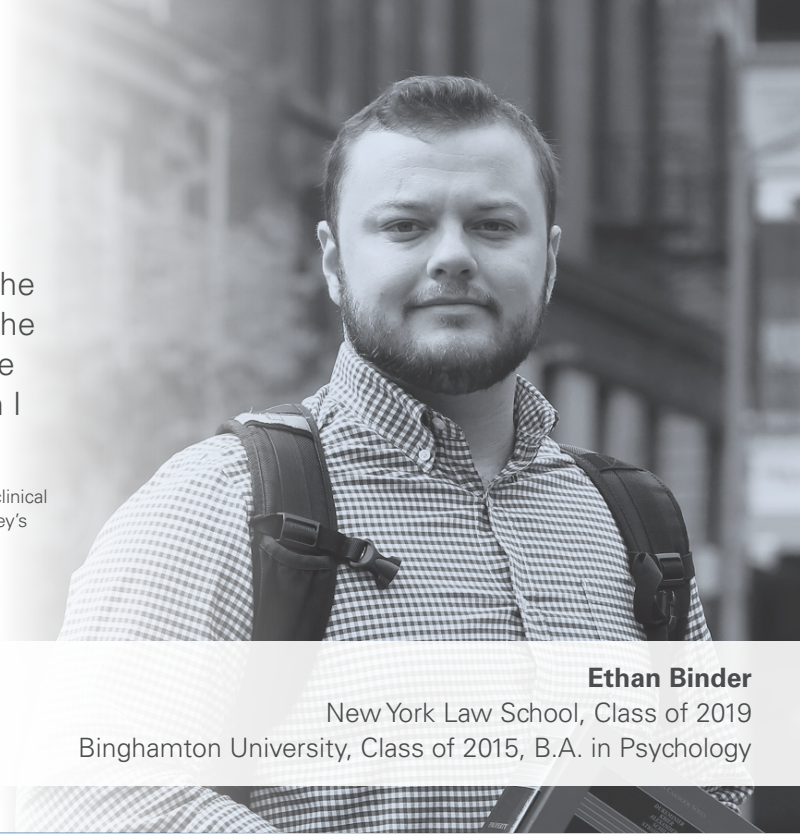
FINANCIAL AID

Official financial aid award notification letters are sent to admitted students on a rolling basis. You will be notified in mid-December at the earliest. The notification letter outlines your cost of attendance and the types and amounts of federal aid for which you are eligible (if applicable). Once you determine the types of financial assistance you wish to accept, you must sign the notification letter and submit a copy to the Office of Admissions and Financial Aid. The Office will not process your award until the signed letter is received. If you have questions about completing and submitting the letter, please contact the Office. The Financial Aid Handbook, located on the Admitted Student Portal, is your primary source for information about financial aid; please review it carefully once you have access to the portal.

Federal Aid: The vast majority of students rely on federal aid to help fund their legal education. The first and most important step in applying for federal aid is to complete the 2019–20 Free Application for Federal Student Aid (FAFSA), found at www.fafsa.ed.gov. For priority consideration, complete the FAFSA by February 1, 2019. You do not need to wait until your 2018 taxes are filed to complete your FAFSA; you can use information from your 2017 tax returns. Parental information is not required for graduate students filing the FAFSA, but those who wish to apply for need-based grants from NYLS must submit it. When completing the FAFSA, you will need NYLS's code. It is **G02783**.

Within a few days of when you file your FAFSA, the U.S. Department of Education will generate your Student Aid Report (SAR). It is imperative that you review your SAR, particularly the comments section, for accuracy. Once your FAFSA is finalized, the Office of Admissions and Financial Aid will review it to determine your eligibility for financial aid.

Merit Scholarships: These awards are offered by the Admissions Committee on the basis of your incoming credentials. After your first year, you may become eligible for additional scholarship funding if you rank within the top 25 percent of the class and accept an invitation to join the Dean's Leadership Council.

HOUSING

NYLS's student housing is in the St. George Residence Hall in historic Brooklyn Heights. The location is a quiet, residential neighborhood one subway stop from Manhattan and approximately 15 to 20 minutes from campus. Each room has a private bathroom, flat-screen television, refrigerator, microwave, twin bed with storage space, desk, chair, and air conditioner.

NYLS will post its housing application on the Admitted Student Portal on June 1, 2019. Prior to that, housing applications will be sent individually to admitted students who have submitted both tuition deposits. Student housing is provided on a first come, first served basis.

STUDENT IMMUNIZATION FORM

This form details your immunization history and is required by New York State law. Ask your health care provider to complete the form.

MENINGOCOCCAL MENINGITIS VACCINATION FORM

This form documents either receipt of the meningitis vaccination or your understanding of the risks associated with not receiving the vaccination.

UNDERGRADUATE TRANSCRIPT

In accordance with American Bar Association (ABA) standards and rules, NYLS requires a final official undergraduate transcript. The transcript must be sent directly to NYLS from the institution where you earned, or will earn, your bachelor's degree.

If you have more than one bachelor's degree, send the transcript from the institution that granted your *first* bachelor's degree. The transcript provided as part of your LSAC Credential Assembly Service report does *not* satisfy the ABA requirement. Unofficial transcripts, those marked "issued to student," and those not sent directly to NYLS by the issuing institution will not be accepted. **Transcripts must be received by July 30, 2019.** Summer graduates and those who have earned their undergraduate degree outside of the United States or Canada should contact the Office of Admissions and Financial Aid to discuss any exigent circumstances that will prevent fulfillment of this obligation by the deadline.

HEALTH INSURANCE

All students taking 8 or more credits will automatically be enrolled in NYLS's student health insurance plan unless they complete the necessary opt-out waiver process, which requires proof of comparable health insurance. Students who do not complete the opt-out waiver process will be responsible for NYLS plan charges. Students who are enrolled in NYLS's health insurance program may also enroll their dependents for an additional fee.

Additional details, including the coverage fee, will be posted on the Admitted Student Portal prior to First Week.

INTERNATIONAL STUDENTS: F-1 VISAS

The Office of Student Life helps international students and their dependents obtain visas.

Only full-time Day Division students are eligible for an F-1 visa. Students who apply for an F-1 visa must provide documentation of their ability to pay for tuition and other expenses, as well as biographical information for the visa application. 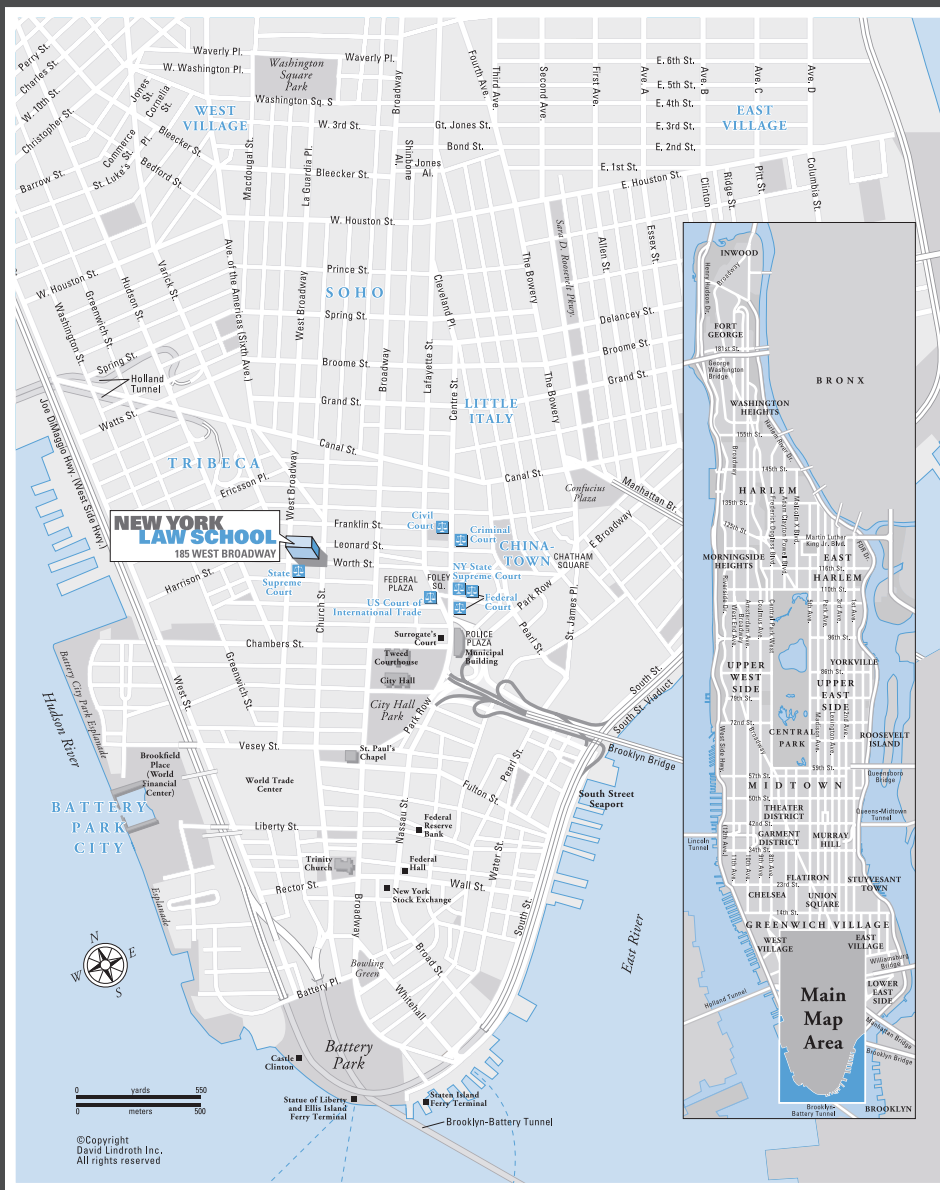

BY SUBWAY
7th Avenue Line

1 (local) to Franklin Street. Exit at Varick Street and West Broadway. Walk one block south on West Broadway. The School is located on West Broadway between Worth and Leonard Streets.

2, 3 (express) to Chambers Street. Exit at West Broadway and walk four blocks north on West Broadway.

Lexington Avenue Line

4, 5 (express), and 6 (local) to Brooklyn Bridge/City Hall. Exit at Foley Square. Walk north two blocks to Worth Street and west four blocks to West Broadway.

8th Avenue Line

A (express) and C (local) to Chambers Street. Exit at Church Street. Walk four blocks north on Church Street to Worth Street. Walk one block west to West Broadway.

E (local) to Canal Street; change for the A or C to Chambers Street.

Avenue of the Americas (Sixth Avenue) Line
B, D, Q (express), and F (local) to West 4th Street/Washington Square. Change at West 4th Street for the A or C to Chambers Street.

Broadway Line

W, R (local) to City Hall. Exit on Broadway and walk north on Broadway to Worth Street. Walk west on Worth Street two blocks to West Broadway.

Nassau Street Line

J, Z (express), and M (local) to Chambers Street. Exit at Foley Square. Walk north two blocks to Worth Street and west four blocks to West Broadway.

BY BUS

M1, M6 south to Broadway and Worth Street. Walk two blocks west on Worth Street to West Broadway.

M20 south to West Broadway and Worth Street.

BY CAR

From the Harlem River Drive/FDR Drive

Take Exit 2 (Brooklyn Bridge/Civic Center). Bear right toward Civic Center and proceed down ramp. Make a right at the light onto St. James Place.

Go straight; at the third light (street ends), make a left onto Worth Street. Continue for approximately six blocks.

From the Henry Hudson Parkway/ West Side Highway

Take the Chambers Street exit. Follow Chambers Street three blocks and make a left onto Church Street. Follow Church Street five blocks to Leonard Street. Make a left onto Leonard Street. Go one block west to the corner of Leonard and West Broadway.

From the Brooklyn Battery Tunnel

At the tunnel exit, bear right onto Trinity Place. (Trinity Place becomes Church Street after the World Trade Center site.) Move to the far left lane. Continue on Church Street to Leonard Street. (Leonard Street is five blocks past Chambers Street.) Make a left onto Leonard Street and go one block west to the corner of Leonard and West Broadway.

From the Holland Tunnel

Stay in the middle lane and take the "Downtown" exit. Make a right onto Varick Street. (Varick Street becomes West Broadway.) Continue on West Broadway two blocks to Leonard Street.

From the Lincoln Tunnel

Take the West Side Highway south. (Refer to directions from West Side Highway.)

Note for N.J. Visitors

Take the PATH train to the World Trade Center. Exit at West Broadway and walk north approximately 10 blocks to New York Law School.

Parking

There are a number of parking garages in the neighborhood for paid parking. On-street parking is extremely limited.
